## 1. LEARNERS RIGHTS

- 1.1 Every learner has the following rights:
- 1.1.1 To be informed about the code of conduct;
- 1.1.2 To freedom of speech and to voice their opinion in a matured, tactful and appropriate manner;
- 1.1.3 To be respected by other members of the school community, regardless of personal, religious or cultural differences;
- 1.1.4 To be treated with fairness;
- 1.1.5 To work in a clean and litter-free environment;

## 2. OBLIGATIONS OF LEARNERS

- 2.1 Every learner has the following responsibilities:
- 2.1.1 To be willing to receive correction and discipline from any members of the staff of the school;
- 2.1.2 To be willing to receive instructions from any members of the staff of the school;
- 2.1.3 To respect staff members including non-teaching staff;
- 2.1.4 To do all assignments, class-work, home-work, experiments, practical work or activity assigned to learners;
- 2.1.5 To respect the decision made and react to them in a matured and sensitive manner;

2.1.6 To take a good care of the text books and return them as you received them;

NB: Any violation of any of the listed obligations shall be dealt with by the relevant authority and the learner shall be liable to an appropriate punishment.

## ACTS OF MISCONDUCT

- 1.1 The following acts of misconduct shall constitute LEVEL 1 MISCONDUCT (FIRST INSTANCE OFFENCES)
- 1.1.1 Failure to be in class on time;
- 1.1.2 Failing to finish home-work;
- 1.1.3 Failing to respond to reasonable instructions
- 1.1.4 Writing on the wall;
- 1.1.5 Wandering around without good reason during teaching sessions;
- 1.1.6 Cleaning of dusters on the walls;
- 1.1.7 Use of vulgar language or abusive language in the class or within school premises;
- 1.1.8 Boys wearing earrings and girls wearing more than one pair of earrings;
- 1.1.9 Wearing hats and caps in the school premises that are not school uniform;
- 1.1.10 Removal of furniture from the class without the permission of an authority;
- 1.1.11 Applying lipsticks or nail polish
- 1.1.12 Absenteeism without valid reason;
- 1.2 The following acts of misconduct constitute LEVEL 2 MISCONDUCT (SECOND INSTANCE OFFENCES)
- 1.2.1 Frequently repeated level 1 misconducts;
- 1.2.2 Possession or use of cellphone in the classroom as well as in the school premises;
- 1.2.3 Possessing dangerous weapons;

- 1.2.4 Possessing or distributing pornographic, racist or sexist materials;
- 1.2.5 Racist, sexist or other discriminatory behaviour;
- 1.2.6 Forging documents or teachers signatures;
- 1.2.7 Smoking or carrying tobacco;
- 1.2.8 Throwing litter around school premises;
- 1.2.9 Visiting the toilets during class times, unless by permission and messing up in the toilets;
- 1.2.10 Interrupting lessons in the classrooms;
- 1.2.11 Gambling
- 1.2.12 Bullying of other learners and educator
- 1.3 The following acts of misconduct constitute LEVEL 3 MISCONDUCT (THIRD INSTANCE OFFENCES)
- 1.3.1 Repetition of offences listed in level 2 misconducts;
- 1.3.2 Cheating during class tests;
- 1.3.3 Cheating during examination;
- 1.3.4 Causing intentional injury to another person;
- 1.3.5 Verbally threatening the safety of another person;
- 1.3.6 Disrupting the entire school (e.g. boycotting or picketing without consent);
- 1.3.7 Leaving classroom without permission;
- 1.3.8 Leaving school premises without permission;
- 1.3.9 Initiating a bribe involving examination material;
- 1.3.10 Minor and major theft;
- 1.3.11 Vandalism;
- 1.3.12 Extortion of another person's property;

## PENALTY AND DISCIPLINARY PROCEDURE

- 1.1 In the event that the learner commits any misconduct of the FIRST INSTANCE OFFENCE, these are some of the disciplinary actions which will be taken by the school:
  - 1. Disciplinary talk with the learner
  - 2. Talk with the learner's parents or guardians
  - 3. Written warnings

- 4. Performing duties that improve the school environment such as cleaning, gardening etc.
- 1.2 In the event that the learner commits an offence listed in the SECOND INSTANCE, a learner shall be referred to the principal and the principal in her absolute discretion shall decide to reprimand a learner or refer the matter for an enquiry, in this case the disciplinary forum shall impose an appropriate sanction on a learner if found guilty.
- 1.3 In the event that the learner commits an offence listed in the THIRD INSTANCE, the matter shall be referred to disciplinary forum for a fair hearing and if a learner is found guilty of an offence. The sanction to be imposed shall include a suspension from studies at school.
- 1.4 A disciplinary forum shall have the right to impose any sanction on a learner provided that such sanction is fair, equitable, reasonable and in accordance with any applicable and relevant legislation and regulation.
- 1.5 A learner shall have a right to challenge evidence against him/her and be assisted by a parent/guardian or a fellow learner.
